- Encouraging HSSE ownership, empowering our workers with the authority to speak up and to report any unsafe work practices and unacceptable behaviours.
- Encouraging our workers to maintain a positive mental health, actively promote the prevention of work-related injury and ill health and supporting injured workers to return to work.
